I am interested in obtaining approval from the IN Board for our organization, "Continuing Education and Development, Inc." as an online continuing education provider for professional engineers. 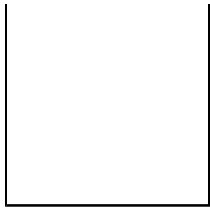
